In case you missed donating at the TCMA Holiday Luncheon, here's your chance. Please include TCMA in the note box when making your contribution.

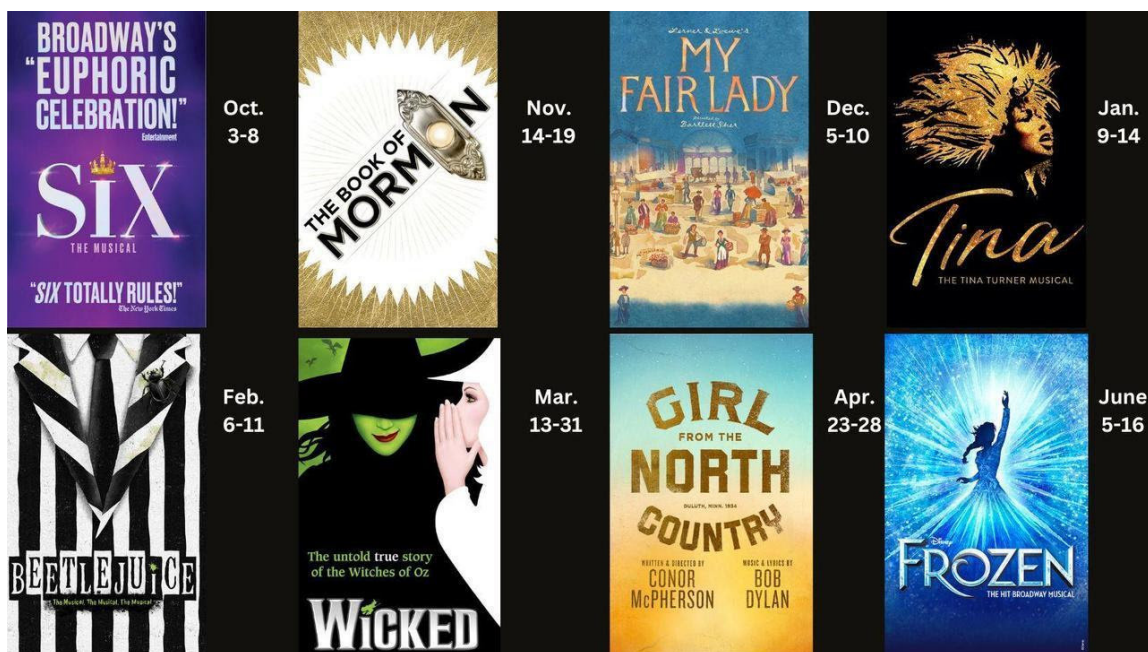
